
#### **Foundation Funding**

Resident involvement and interest has shaped the direction and focus of Foundation funding, leading to a wide range of projects and services benefitting Casa de las Campanas residents. Foundation funding from inception through December 31, 2018, totaled \$7.154 million.

Since inception, a variety of capital projects and programs have received Foundation support. The Palmer Special Care Residence tops the list of supported projects at \$3.15 million, with a lead gift from resident philanthropist Freda Palmer of \$2 million. Other major categories include resident hardship funding of \$1,186,678, health-related funding of \$705,056, and education/scholarship funding of \$779,642.



They provide a permanent base of support for funding needs. As of July 31, 2018, the Foundation's endowments totaled more than \$6.8 million.

#### **Charitable Gift Annuity Program**

Most people want to know that they can always count on income from their investments, which is why our Charitable Gift Annuity program is so popular. It's a solution that our residents can count on. Not only are income rates attractive.

they are guaranteed for life and backed by the assets of Casa de las Campanas. Any remainder left in the account at termination is used by the Casa Foundation to further its mission and purpose in the community.

In exchange for particippting in the program, Casa agrees to pay a fixed income for life to



the named beneficiaries of the contract. We offer the maximum rates published by the American Council on Gift Annuities, based on age, which typically range between 6% and 9.5% for Casa residents. Steady income isn't the only advantage. In addition to a hefty income tax deduction, a portion of the income received is treated as tax-free. Gift annuities are flexible and can be set up to benefit children or other loved ones. Best of all, charitable gift annuities allow our residents to become involved as philanthropists. A minimum of \$15,000 in cash or securities is all that is required to participate.

## **MILESTONES**

1994 Casa Foundation was incorporated and charitable remainder trusts were established by David & Ellie Harper and Lenore Bordeau for the benefit of the Casa Foundation.

1995 The Casa Foundation Resident Advisory Committee was formed to support growth of the Foundation and to advise the Board of Directors.

1996/97 The Casa Foundation received its first bequest from the estate of Russell & Lydia Hogan & a major gift enabled the purchase of the Bluebird bus for resident transportation.

1998 The Foundation general endowment was officially christened the Tilburg General Endowment in honor of Bill & Elsie Tilburg.

1999 The Carpenter Activities Endowment was put in place by Peggy Carpenter as the first resident-established endowment.

2000/01 Justin & Phyllis Radin underwrote the purchase of a player grand piano for the Health Center & the Nelle O'Brien Continuing Education Fund was established in Nelle O'Brien's honor.

2002 The Caring for Life campaign, chaired by Richard Ormsby and Dr. John Ingle, raised over \$3 million to assist in building the Palmer Special Care Residence.

2003 Gift Annuity contracts in excess of \$700,000 were put in place for the benefit of Casa residents.

2004 A ground-breaking ceremony recognized Freda Palmer for her \$2 million gift to build the Palmer Special Care Residence.

2005 George & Patricia Wynhoff put plans in place for future funding of a major health endowment.

2006 The Foundation received gifts of \$100,000 for the Bell Tower Park and \$70,000 for the purchase of a new Casa bus.

2007/08 174 donors contributed \$161,240 to the "We Care" campaign for resident hardship.

2009 Resident gifts provided support for the purchase of a needed wheelchair-modified van.

 $2010\,\mathrm{Adrian}$  Newman left a major bequest to establish the Newman Care Endowment for the support of the Resident Hardship Program.

2011 The King General Endowment was established with a bequest from Bruce and Marjory King.

2012 A Gift from the estate of Harriet Maclean established the Maclean General Endowment.

2013 *Milestones in Philanthropy*, a historic account of the Foundation, was produced in tandem with Casa's 25th anniversary.

2014 The Cliff & Ethel Barkell estate provided a major gift to establish the Barkell Transportation Endowment.

 $2015/16\,\mathrm{Foundation}$  assets and endowment funds reached new heights with assets totaling over \$7 million by the end of fiscal 2016.

2017/18 The Alice Green Scholarship Endowment, the Levinson Norte Library Endowment, the Carol & Bob Shogren Scholarship Endowment, and the Selma Johnson Scholarship Endowment were established during fiscal 2017 and 2018. Revenue for fiscal 2018 exceeded \$2 million, making it an exceptional year.
